| 1:15 – 1:30 pm | <p>Managing Budgets: Planning, Prioritizing, and Allocating</p> <p>Developing strategies to maintain and increase investments in graduate education is a key factor in the success of a graduate dean. Budgeting requires analysis, personnel management, strategic planning, risk-taking, prioritizing, resource allocation, and many decision-making strategies. It also requires the ability to clearly articulate the value proposition of graduate programs and the graduate school. This session will provide an overview of principles for securing and allocating a graduate dean’s budget.</p> |
| 1:30 – 1:45 pm | <p>Managing Operations: Time, Staff, and Partnerships</p> <p>Whether a graduate school has a large staff and complex structure or lean staff and simpler structure, its dean must be adept at using his or her time effectively and efficiently, delegating responsibility to staff members and monitoring workflow, and forging partnerships with central administrative units, campus graduate programs, and graduate faculty and students.</p> |
