

Individual Legislative Proposals to Address COVID-19

As of 6/12/2020

Aside from large stimulus packages encompassing sections of various federal departments and agencies, several lawmakers have introduced individual proposals to address more particular issues or to provide language that can be wrapped into a larger package. Below is a running list of legislative proposals introduced that may affect the graduate education community. The chart below will continue to be updated as new legislation is introduced.
