
Scholarship Award: \$15,000



Robert (Bob) Moses Scholarship

This annually awarded national scholarship is designed to support the educational goals of a graduate student from an underrepresented group who is pursuing a master's or doctoral degree in mathematics education or a STEM discipline. The individual should also have a commitment to civic engagement.

The inaugural scholarship is named in honor of the late Bob Moses, a pioneering civil rights leader and educator who founded The Algebra Project, a national U.S. mathematics literacy program aimed at helping low-income students and students of color achieve the mathematical skills in high school that are a prerequisite for success in college and beyond.



Scholarship Award: \$15,000

Lenora M. Green Scholarship

This annually awarded national scholarship was established to support the educational goals of an undergraduate student who shows outstanding commitment to civic engagement along with a spirit of advocacy for serving individuals who have been systematically excluded.

The inaugural scholarship is named in honor of the late Lenora M. Green, the former Executive Director of the Center for Advocacy & Philanthropy at ETS. A fierce advocate for educational opportunities for underserved students, Green was committed to civic engagement.


What Is Changing

- Beginning September 22, 2023, testing time will be reduced by half, from nearly four hours to just under two, and students will receive scores in 8-10 days (currently 10-15 days).
- The number of questions in the Verbal Reasoning and Quantitative Reasoning sections will be reduced.
- The number of writing tasks will be reduced from two to one.
- The unscored section will be removed
- The scheduled 10-minute break, which comes more than two hours into the current GRE, will be removed since the test is now under two hours (except for those who are approved for that accommodation).



What's Not Changing

- The test will continue to measure the same skills and construct and maintain the strong quality and security the GRE is known for, with valid and reliable scores for confident decision-making.
- The score scales will remain the same so score users can easily compare performance across cohorts who tested before and after September 2023.
- The sections will not change, though there will be fewer questions/tasks in each.
- Pricing will not change, though we are currently offering a summer discounts through September 20. Also, the reschedule fee will be waived for students who are already registered after September 22, 2023, should they wish to take the longer test instead.

Answers to Frequently Asked Questions About...

Validity

The changes we're making are the result of analysis by — and discussions with — our assessment development and psychometrics teams about how to introduce a better experience for test takers while retaining the strong validity and reliability schools need for confident decision-making. The shorter GRE retains an appropriate level of reliability for high-stakes decisions that ensures comparability between the tests.

Test prep

Updated prep will be available this fall, but as all sections and question types will be the same, test takers can continue to use existing GRE test prep to prepare.

Advising Students

This summer, students can choose to either take the current GRE before September 20 or the shorter GRE September 22 or later. There is no overlap period when both versions are available.

In advising students which test to take, it's best for them to first consider their application deadlines. Those whose deadlines are the first week of October or sooner should take the current test.

If deadlines are not an influencing factor, students should consider their preferences related to seat time and comfort with writing, as well as whether they think more or fewer questions will be an advantage for them.





Comparing the Current and Shorter GRE® General Test

The world's most widely used test for admission to graduate and professional programs, including business and law, is getting better! On September 22, 2023, the GRE General Test will be shortened from just under 4 hours to just under 2, and will report scores faster, helping you submit your applications sooner! 

TOEFL iBT® Enhancements

Changes taking effect July 26, 2023



Key Changes to the TOEFL iBT

- Removing unscored items
- Streamlining test instructions
- Removing one reading passage and associated questions
- Replacing the 'Independent Writing' task with 'Writing for an Academic Discussion' task

Effective July 26, 2023, these enhancements put the TOEFL iBT test time just under 2 hours while maintaining its reliability

About the New "Writing for an Academic Discussion" Task

The test taker is expected to:

- respond to or build on ideas expressed in other text
- clearly state or elaborate on a position or argument
- show accurate and meaningful use of a range of grammatical structures and vocabulary in the academic context
- This task demonstrates proficiency in a shorter time with the same high level of reliability and validity



Same Trusted Score Scale

- The test will still provide programs with the trusted scores you rely on for confident decisionmaking regarding applicants
- There are no changes to the score scale and programs will not need to change their score requirements
- Schools can continue to receive scores the same way you receive them now

What research supports the development of PSQ?

- A substantial body of research, including seminal work by ETS leaders in the field of interpersonal and intrapersonal skills.
- PSQ has been verified in close collaboration with higher ed institutions and employers, including the Yale School of Management.



Leading this work is ETS Distinguished Presidential Appointee Patrick Kyllonen of our Education and Career Development research center.


His work focuses on the assessment of interpersonal and intrapersonal skills for higher education and workforce readiness.

He is the author of several books and National Academy of Sciences reports on these topics and is a fellow of APA and AERA — two organizations that set industry standards for educational assessment.



Format and learner experience

- Learners are shown pairs of statements and asked which is most like them
- Learners provide responses to 130 statements in 20-30 minutes on mobile device or computer







How is PSQ resistant to faking?

- The two statements that learners are presented with are of equal appeal (or lack thereof), and therefore, applicants will be unable to guess which answer makes them sound "best."
- In addition, unless you divulge the skill dimensions your program is interested in, they will **not be known** to the learner, making such guessing even more difficult.
- The inability to prepare for or game this assessment **minimizes** the chances of any learner having an unfair advantage over another.





How can PSQ be used?



PSQ can be used to inform **pre- and post- admission decisions** based on program needs by providing insights into behavioral characteristics that are critical for success. Insights from the tool may also be used to inform institutions' goals related to diversity, holistic admission and cohort development.



PSQ can be used to inform **learner development.** The information collected from the PSQ will allow you to better direct efforts and resources to support learner development more effectively, particularly incoming students, as well as support your program's continuous improvement initiatives and assurance of learning process.





How can PSQ be used?



PSQ results can be used by learners to aid in their own **personal development.** PSQ results provide learners with information about themselves that they can use to take action to develop skills essential for success. Learners can also use greater self-awareness of their strengths and weaknesses in putting together personal statements and other materials for graduate and professional schools, and in interviews for school and the workforce.





Learner experience feedback

 91% of all learners surveyed answered agree/strongly agree to the statement "...schools should consider my skills and experiences beyond academic measures...when reviewing my graduate school application."

How learners have described their PSQ experience:

- "I liked that the assessment addressed multiple aspects of my character."
- "I liked that it was simple and easy to use."
- "That kind of thought-exercising I find to be very enjoyable, and I hope that it captures an accurate reflection of not only who I think I am but who others think that I am as well."
- "I enjoyed the format."
- "I liked that some of the questions challenged me, and I had to actually stop and consider which of the choices most and least described me (was especially difficult when all of them were applicable to me or none of them were).
- "The assessment helped me think introspectively and challenged what i though about myself."
