Develop and lead strategic initiatives to enhance inclusiveness in the graduate community through programs, advocacy, and research.

Develop and advance best practice initiatives that strengthen CGS members' capabilities to fulfill their mission.

Serve as the organizational representative to associations, boards, and agencies related to the mission of higher education.



Organize and convene major events bringing together graduate deans and other stakeholders to discuss and take actionable steps on issues affecting graduate education.

Extend the voice and impact of the CGS internationally.

Ensure that all activities and programs of the Council are aligned with the highest standards of ethics and with the CGS mission.

Develop, collaborate, and engage with corporate and non-profits sectors to advance the mission of the CGS.
